The Board approved the alteration of 'Objects of The Issue' for the initial public offer (the "Issue" or "IPO") for which an amount of ₹ 5,440.00 Lakhs was raised through a prospectus filed with the Stock Exchange on 5th April, 2024. The net proceeds from the Issue were ₹ 4960.35 Lakhs (hereinafter referred to as "IPO Proceeds"), the utilization of which are as follows:
