- Scrutinizer Report of Postal Ballot (Remote E-voting) by the Members of Creative Graphics Solutions India Limited ("cut-off date") and who had registered their email ID with the Company / RTA / Depositories in compliance with the MCA Circulars. The Company has also placed the notice of the Postal Ballot on the website of the Company.
